What is this product?

Type: Shares of a Sub-Fund of MULTI UNITS FRANCE, a SICAV.

Term: The Sub-Fund is open-ended.

AMF Classification ("Autorité des Marchés Financiers"): Eurozone country equities

Objectives: The fund is a passively managed, index-based UCITS.

The Fund's objective is to replicate, both upwards and downwards, the performance of the EURO STOXX 50 Net Return Index (net dividends reinvested) (the "Benchmark Index"), denominated in euro (EUR) and representative of 50 blue-chips in the Eurozone while keeping the tracking error (the "Tracking Error") between the performances of the Fund and those of the Benchmark Index to a minimum.

The expected Tracking Error under normal market conditions is set out in the Fund's prospectus.

The website <http://www.stoxx.com/indices> provides more detailed information on the Benchmark Index.

The Fund aims to achieve its objective through direct replication, i.e. by investing mainly in a basket of assets comprising the securities that make up the Benchmark and/or eligible financial instruments that are representative of all or some of the securities that make up the Benchmark. In order to optimise Benchmark replication, the Fund may use a sampling technique as well as guaranteed temporary sales of securities.

The updated composition of the portfolio of securities held by the Fund is

mentioned on the website amundiETF.com.

Furthermore, the indicative net asset value is shown on the Reuters and Bloomberg pages of the Fund and may also be shown on the websites of the Fund's stock exchanges.

The Fund is eligible for the French Equity Savings Plan (PEA) and therefore invests a minimum of 75% of its assets in shares of companies in the European Union.

Intended retail investors: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds, seeking to increase the value of their investment over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

Redemption and transaction: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the MULTI UNITS FRANCE prospectus.

Distribution Policy: As this is a non-distributing share class, investment income is reinvested.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- EUR 10,000 is invested.

How long should I hold it and can I take money out early?

Order Schedule: Orders to buy and/or sell (redeem) shares received and accepted by 05:00 pm on any business day in France are ordinarily processed on the same day (using the valuation of that day).

You may exchange shares of the Sub-Fund for shares of other sub-funds of MULTI UNITS FRANCE in accordance with the MULTI UNITS FRANCE prospectus.
